The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours on 2078/02/25 at the office of Khaptad-Chhededaha Rural Municipality, Office of the Rural Municipal Executive. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the validity period of the bid.
